#### MANDATORY CONDITIONS

##### Film exhibitions

(a) Subject to subsection (b) below, the admission of children to the exhibition of films on the premises shall be restricted in accordance with any recommendation made by the British Board of Film Classification (BBFC)

(b) If the licensing authority does not agree with the category of any film as recommended by the BBFC, it may alter the category of the film. On notice of alteration of category being given by the licensing authority to the holder of the licence, the film shall thereafter be treated as being in the altered category and admission of children to the exhibition of the film shall be restricted accordingly

#### MANDATORY CONDITIONS FOR ENTERTAINMENT

- 1) Any outbreak of FIRE, however slight MUST be reported to Guildford Borough Council at once.
- 2) This licence only applies to entertainment inside the premises and does not authorise Public Entertainment in any garden or other outside area. In the event that it is intended to hold Public Entertainment outside, a separate application must be made.
- 3) EXIT lights signs are to be illuminated during performance.
- 4) Emergency exits shall not be hidden behind curtains or scenery and the EXIT doors are to open easily (without the use of a key).
- 5) Secondary lighting shall be tested on a regular basis to ensure that it is in working order.
- 6) Only sockets that are RCB 30mA protected are to be used for stage-lighting and band equipment.
- 7) Laser lighting and effects can only be installed or operated with the express permission of the Council.
- 8) All Doorstaff employed at the venue shall be registered with the Security Industry Authority

##### CAPACITY

The maximum number of persons on the premises must not exceed 269
